## ADVOCATE

**Promote responsible mining** through advocacy efforts at State and Federal levels. In the halls of the State Capitol, MiningMinnesota engages with legislators and their staff to provide critical input for proposed legislation and regulations. On a federal level, we partner with National Mining Association (NMA), American

Exploration and Mining Association (AEMA), and Women's Mining Coalition (WMC) on comment letters, congressional testimony, and engagement with lawmakers.

**Share our members' exploration/mining experiences and perspectives with decisionmakers.** We bring the stories of those with "boots on the ground" to folks who haven't had the privilege to create their own stories and who may not have first-hand knowledge of how regulations play out in real life.



## EDUCATE



**Provide science-based educational materials and presentations and support workshops** for teachers, including the Minnesota Earth Science Teachers Association and the Minnesota Minerals Education Workshop (MMEW). **Engage in conversations** with the public through panel discussions, speaking engagements, and participation in events and gatherings, including a presentation at the TEDx Silver Lake.

**Build knowledge-sharing relationships** with members of industries tied to resource development, supply chain management, manufacturing, and end uses to foster responsible economic development.

**Amplify our message and build support** throughout our state and beyond with regional trade associations, community organizations, advocacy organizations, chambers of commerce, and economic development groups.
